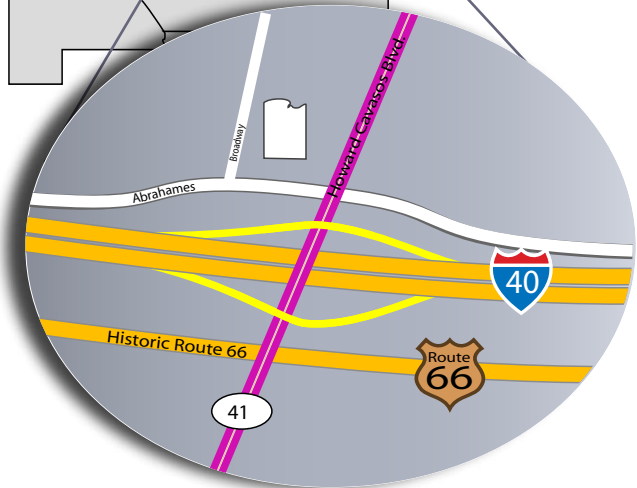


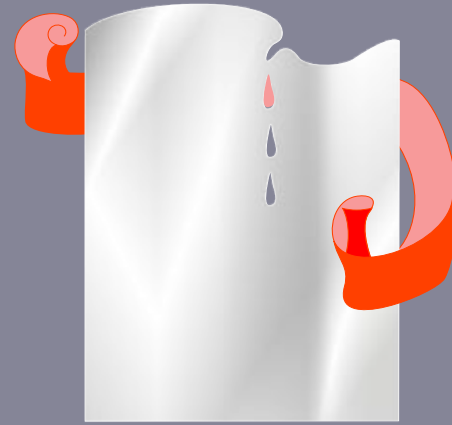

Dear New Mexico Legislators of the 2007 Legislative Session:

The nightmare that was the death of my son by a drunken driver became the birth of a dream for a memorial. In 2006, my dream became a reality through funds from the bill you passed in 2005 and monies, land, supplies, architectural plans, and labor donated by the community of Moriarty and citizens of New Mexico.

On October 14 of 2006, the City of Moriarty dedicated the Memorial of Perpetual Tears Park. Attended by volunteers, contributors, law enforcement, business leaders, dignitaries, and our guest speaker, Glen Birch, National President of MADD, we saw this grassroots movement by the citizens of Moriarty evolve into this unique and special place where survivors and their families can come together to pay tribute and to find comfort and purpose to the tragedy that results from drinking and driving.

Inside this brochure is a timeline of the activities we have accomplished in the past 6 years and we thank you for your support.

We have been careful in the stewardship of our funds, but we did not anticipate the twofold increase of construction costs as a result of Katrina. Funding is needed for the educational building with video center and educational materials, parking lot, pathways, and landscaping, and we ask that you support our request of approximately \$900,000.

Due to recent tragic events, I know that all of you are entering the 2007 legislative session with a renewed purpose to help solve



New Mexico's DWI problem and we ask that you support our request for additional funds for the Memorial of Perpetual Tears.

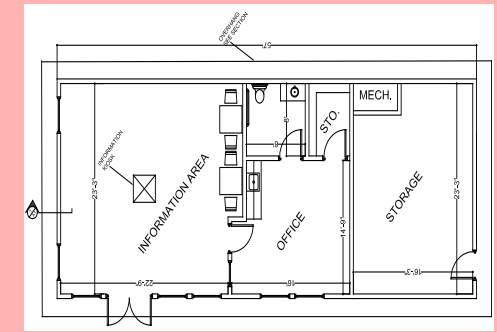
